1. Estynwyd groeso cynnes i bawb gan y Cadeirydd Alwyn Roberts.

Roedd ymddiheuriadau gan Cyng Lona Harris a Eurgain Haf Davies. Gwahoddwyd ddatganiadau o ddidordeb am faterion ar yr agenda. Nid oedd unnrhyw ddatganiadau.

2. Cyflwyniadau gan aelodau o'r cyhoedd ar fater ar yr Agenda.

Nid oedd unrhwy aelodau o'r cyhoedd yn bresennol.

3. Cadarnhawyd gofnodion y cyfarfod a gynhaliwyd ar y 27ain Ionawr 2025 ar gynnig Cyng. Rhys Williams a'i eilio gan Cyng WRP Jones.

4. Materion yn codi a materion eraill.

- a) **Neuadd Llanegryn** – nid oedd unrhwy ddiweddaraid, a byddai'r Clerc yn cael gair gyda Cyng Eurgain Davies. Byddai yn son am yr yswiriant i'r Ymddiriedolwyr, a gofyn os oedd modd cael pris ar gyfer hyn.
- b) **Gardd Goffa** – adroddwyd am y datblygiadau yn ddiweddaraf, a thrafodwyd y canlynol;
 - Darllenodd y Clerc ddau e-bost gan Mr W Willimas – Wynne, ond yn anffodus nid oedd am dderbyn gwahoddiad i agor yr Ardd. Ar gynnig Cyng William Davies a'i eilio gan Cyng Catrin Rutherford, penderfynwyd gofyn i Liz Saville Roberts AS, gyda Mabon ap Gwynfor yn ail enw.
 - Arwyddion ger yr Eglwys - nodwyd e-bost gan Elaine Anikey yn cadarnhau fod angen cysylltu gyda'r Warden, sef Mr W Williams Wynne. Addawodd Cyng Catrin Rutherford i ymdrin a hyn. Awgrymwyd rhoi arwydd rhwng y lynch gate a'r gornel, a'i roi ar bostyn ar y darn tir yno.
 - Trefniadau agoriad swyddogol -- cadarnhawyd eto Nos Lun y 23ain o Fehefin 2025 fel dyddiad i agor. Nodwyd nifer o wahoddedigion i fod yn bresennol a byddai'r Clerc yn cysylltu.
 - Arwydd ar y garreg – nodwyd e-bost gan I B Williams a'i Fab yn rhoi pris o £477.00 yn cynnwys VAT. Byddai yn llechfaen Gymraeg 10" x 10" X ½" gyda'r geiriau GARDD GOFFA LLANEGRYN ; AGORWYD 23.06.25'. Cytunwyd yn unfrydol i hyn, a byddai'r Clerc yn cysylltu
 - Hau hadau/ cael turf ayyb – addawodd y Clerc gysylltu gyda Cyng Eurgain Davies.

- Claddu llwch – trafodwyd safleoedd claddu ayyb – roedd Cyng Beth Lawton wedi son wrth Gyngor Gwynedd, a byddai rhaid trafod eto yn y cyfarfod nesa
- Roedd yr asesiad risc wedi ei gwblhau gan y Clerc. Dosbarthwyd i'r Cynghorwyr, a chytunwyd ar y cynnwys.

b) Llwybr sy'n arwain at y cae chwarae – roedd y Clerc wedi edrych ar wefan y Gofrestrfa Tir, ac nid oedd yn ymddangos fod y tir dan sylw gerllaw wedi ei gofrestru. Gofynnwyd i gysylltu ymhellach gyda Chyngor Gwynedd ynglyn a hyn, gan fod y llwybr yn bwysig i'r pentref.

DYDDIAD CYFARFOD NESAF; CYFARFOD BLYNYDDOL YN Y NEUADD, LLANEGRYN NOS LUN 28ain EBRILL 2025, 7.30y.h.

Minutes of a Council Meeting held on Tuesday, March 4th 2025 at 7.30pm in Ty Newydd, Llanegryn.

Present; Cllr. Alwyn Roberts, William T Davies, Catrin Rutherford, WRP Jones, Rhys W Williams, Beth Lawton (Gwynedd Council) and Huw T Jones (Clerk)

1. A warm welcome was extended to everyone by Chairman Alwyn Roberts.

There were apologies from Cllr Lona Harris and Eurgain Haf Davies.

Expressions of interest were invited for issues on the agenda. There were no statements.

2. Presentations by members of the public on an issue on the Agenda.

No members of the public were present.

3. The minutes of the meeting held on 27th January 2025 were confirmed on the proposal of Cllr. Rhys Williams and seconded by Cllr WRP Jones.

4. Matters arising and other matters.

a) Llanegryn Hall - there was no update, and the Clerk would have a word with Cllr Eurgain Davies. He would mention the insurance to the Trustees, and ask if it was possible to get a price for this.

b) Memorial Garden - the most recent developments were reported, and the following were discussed;

- The Clerk read two emails from Mr W Williams - Wynne, but unfortunately he did not want to accept an invitation to open the Garden. On the proposal of Cllr William Davies and seconded by Cllr Catrin Rutherford, it was decided to ask Liz Saville Roberts MP, with Mabon ap Gwynfor as the second name.
- Signs near the Church - an email from Elaine Anikey was noted confirming the need to contact the Warden, Mr W Williams Wynne. Cllr Catrin Rutherford promised to deal with this. It was suggested to put a sign between the lynch gate and the corner, and put it on a post on the piece of land there.
- Official opening arrangements - confirmed again on Monday evening the 23rd of June 2025 as a date to open. A number of invitees were identified to be present and the Clerk would be in touch.
- Sign on the stone - an email was noted from I B Williams & Son giving a price of £477.00 including VAT. It would be a Welsh slate 10" x 10" X ½" with the words GARDD GOFFA LLANEGRYN; AGORWYD 23.06.25'. This was unanimously agreed, and the Clerk would contact

- Sowing seeds/getting turf etc - the Clerk promised to contact Cllr Eurgain Davies.

Burial of ashes - burial sites etc were discussed - Cllr Beth Lawton had spoken to Gwynedd Council, and it would have to be discussed again at the next meeting

- The risk assessment had been completed by the Clerk. It was distributed to the Councillors, and the content was agreed.

b) The path that leads to the playing field - the Clerk had looked at the Land Registry website, and it did not appear that the land in question nearby was registered. We were asked to contact Gwynedd Council further regarding this, as the route is important to the village.

5. Planning Matters

One application had been distributed since the last meeting, viz

NP5/64/LB58C – Bodegryn, Llanegryn

Listed Building Consent to re-install external render, paint, windows to the rear and install leaded glass and renew lead on the front bay windows.

This had been circulated, and Councilors were supportive, as it was an improvement to the building.

Guidelines for Community Councils were identified by the Planning Department of the National Park which had been circulated to everyone. With the consultation of planning applications, it was noted that one must either SUPPORT (with reasons) or REJECT (with reasons)

6. Finance Matters.

a) The bank's Mandate – it was all ready to be delivered to HSBC.

b) Invoices to be paid.

On the proposal of Cllr Rhys Williams and seconded by Cllr Willaim Davies, the following payments were agreed

- Clerk's last quarter remuneration - £400.01 and HMRC payment £100. Also costs for the year as agreed, namely £500.

- Cost of EW Owen and Company - doing PAYE etc throughout the year - £228.00.

c) Consider any requests for money

On the proposal of Cllr WRP Jones and seconded by Cllr Rhys Williams, the following payments were agreed

- Wales Air Ambulance – leave this until the outcome of the Judicial Review

- Cheese Bread Theater - donate £50.

- Meirionnydd Young Farmers Clubs - donate £100.

- GISDA Appeal 40 – it was decided not to contribute.

7. Correspondence.

a) Un Llais Cymru training dates - it was noted that no dates were available. It was confirmed that the training plan is on the website

b) Ysgol Craig yr Aderyn - a request was received from Cllr Beth Lawton (Gwynedd Council) for a representative on the Governors. It would have to be discussed at the next meeting.

c) Toilets in Llanegryn - it was noted that improvements are needed there, and a price for putting a sink etc. The Clerk was asked to contact Danny Blake in the first instance.

Shan was thanked very much for all her work, and it was decided, on the proposal of Cllr Rhys Williams and seconded by Cllr Catrin Rutherford, to organize flowers for her at a cost of £30. Cllr Beth Lawton promised to be in charge of this, and we were very grateful.

d) Appointment of Internal Auditor/ Commitment letter - 2024-25 accounts. It was agreed to deliver to Gwynedd Council's internal Audit Unit as usual.

e) Correspondence noted regarding notification confirming article 4 from the National Park.

f) A letter was received from Sian Gwenllian MP seeking support for a Dental School in Bangor. Agreed to this.

g) The North Wales Police and Crime Plan was noted, and the Clerk would distribute it.

h) Correspondence was noted including the Annual Report of the Independent Panel for Wales on financial remuneration.

8. Any other matter.

Cllr Beth Lawton (Gwynedd Council) reported on the latest regarding Ysbyty Tywyn.

It was also reported about a meeting of the full Council on the 6th of March, and the recommendation to raise Gwynedd Council tax for 2025-26 which is 8.66%
